- (c) On the ground of religion, cast or race, place of birth of any of these reasons.

7. The school shall ensure that:-

- (a) no child admitted, shall be held back in any class or expelled from school till the completion of elementary Education in a school;
- (b) no child shall be subjected to physical punishment of mental harassment:
- (c) no child require to pass any board examination till the completion of elementary education;
 - (d) every child completing elementary education shall be awarded a certificate as laid down under rule 21;
 - (e) Inclusion of students with disabilities / special needs as per provision of act;
 - (f) the teachers are recruited with minimum qualifications, as laid under sub-section (1) of section 23; provided that the existing teachers who, at the time of commencement of the Act, do not posses the minimum qualifications, shall acquire such qualifications with in the period of 5 years from the date of commencement of the Act;
 - (g) the teachers perform their dutles, specified under sub-section(1) of 24 of the Act; and
 - (h) The teachers shall not engage himself or herself in any private activities.
- 8. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
- 9. The school shall enroll students proportionate to the norms and standards available in the school as specified in section 19 of the Act.
- 10. The school shall maintain the standards and norms of the school as specified in ocstion 10 of the Act. The facilities reported at the time of last inspection, if made, are as given under :-
